Towards this end, all MDEAs are required to furnish this Ministry with details of all funds accessed from the Treasury on monthly basis using the attached proforma.
- The returns for the months of January to May, 2020 should be submitted to this office on or before 5 June, 2020 while subsequent returns should be submitted within the first week of the succeeding month.
- All Accounting officers are hereby enjoined to ensure strict compliance with the requirements of this circular, please.
