Please note that all admitted Day-Students are expected to pay all the fees in the approved collectibles **except for the boarding fee.** In addition, all Day-Students would be morally obliged to comply with the extant rules and regulations operational in the Schools and those that the Ministry shall from time to time introduce to enhance improvement in the management of the Schools.
