

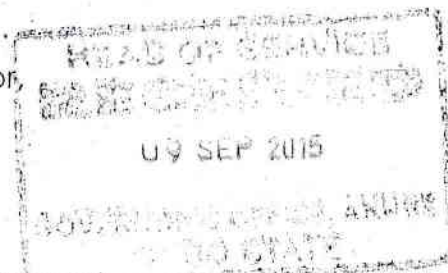

ADEQUATE PUBLICITY OF GOVERNMENT PROGRAMMES BY MINISTRIES, DEPARTMENTS AND AGENCIES [MDAs]

The State Executive Council at its meeting held on Monday, 10th August, 2015 received and considered the Report of the Cabinet Committee on New Communication Strategy. Council noted in particular, that the various Ministries, Departments and Agencies [MDAs] of Government have neither been giving adequate publicity to policies, programmes and activities of Government in their respective MDAs nor liaising with the Ministry of Information for necessary guidance and partnership on media projection of such government activities, as officially required. This development is considered not to be in the interest of the government and the masses to whom the government owes its legitimacy and accountability.

2. Accordingly, government has directed that henceforth all MDAs should give adequate publicity to their programmes in order to keep members of the public abreast of government activities in the State.

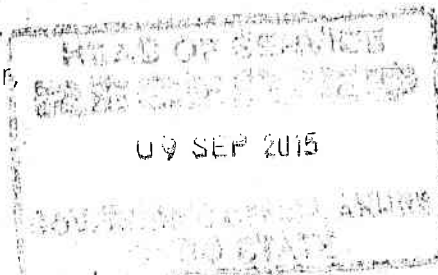
