CREATION OF GRADUATE TEACHERS' CADRE AND ELONGATION

You may please recall that there have been an age-long agitation from the University Graduate-Teachers in the State's Primary Schools system for the creation of the Graduate-Teachers Cadre and elongation of their Career Progression from GL. 14 to GL. 16. The State Government has given consideration to the recommendations of the 5-man Committee constituted to look into the request and has approved as follows:

- (i) The recognition of relevant University Degree as a teaching qualification in the Primary Schools;
- (ii) the career elongation from GL. 14 to GL. 16 for holders of Degree Certificates in relevant courses at the Primary School level.

i) the creation of two separate Cadres in the State Primary School system

thus:

(a) National Certificate in Education Teachers Cadre (GL. 07 - GL. 14)

and

(b) The Graduate Teachers Cadre (GL. 08 - GL. 16) and

(iv) new nomenclatures and career progression for the two (2) Cadres as stated below:
